

  
*Annual Father's Day Car Show*  
Sunday June 15<sup>th</sup> 2008  
Noon to 4PM

**SHOW DESCRIPTION:**

A family oriented "fun" car show and display open to all vehicles and operators willing to meet the subsequent criteria. Held on the Park's south lawn, the show includes a friendly car club competition with awards and prizes in 3 categories; 1) best club display, 2) best of show and 3) people's choice. With judging methodology describe subsequently. The show includes sponsor displays, a food concession and entertainment.

**REGISTRATION:**

A \$5 early registration fee through the Sonnenberg website: <http://www.sonnenberg.org>, the car show website: <http://www.sonnenbergcarshow.org> or by calling Pete, at (585) 944-0717, (585) 396-3224, [pete@canandaiguacan.com](mailto:pete@canandaiguacan.com). Early registration required by June 7, 2008. A \$10 show day registration is required. Registration includes entry to the park for all show vehicle occupants.

**ENTERING THE PARK:**

The park will open for registered show vehicles at 10AM. Enter through the main entrance at the intersection of Charlotte and Howell Streets, Canandaigua NY. Each pre-registrant will be provided with an email or regularly mailed voucher to be shown to the gate attendant. Show day registrants will be required to pay a \$10 registration fee to the gate attendant. The gate attendant will provide directions to the show entry booth. All registrants must stop at the show entry booth to cure their final entry information and display ID's. If you were entered in the 2007 show your entry ID will remain the same as in 2007 (numbers 1 to 100). New 2008 registrants will receive entry ID's beginning with number 201. The practice of retained ID numbers will be continued for future shows; however entrants must pick up a new show ID card to be displayed on all show vehicles. Show entry booth personnel will direct you to the location to park and display vehicles. Trailered vehicles must be unloaded at a location specified by show entry booth personnel. Trailers and tow vehicles must park in the main lot after discharging their show vehicles.

**SHOW REGULATIONS:**

- All show vehicles must have a valid show entry card prominently displayed, or will be directed to leave the show and the park.
- No cooking or alcoholic beverages allowed. Those violating these rules will be directed to leave the show and the park.
- All Park regulations and restrictions apply.
- Garbage is carry-in / carry-out. Entrants are expected to bring your own refuse containers.
- Sonnenberg Gardens and Mansion State Historic Park, and the organizers of the Father's Day Car Show assume no responsibility or liability regarding the status or condition of show vehicles or any damage incurred during the show or while on the Park grounds. The vehicle owner/operators assume all responsibility and liability regarding their vehicles and their show appearance.
- All show vehicles must remained displayed on the show ground until after the award ceremony to be eligible for any of the awards presented
- There will be no registration refunds, for any reason.

**JUDGING**

**I. Best Club Display:**

Clubs are encouraged to promote their respective organizations and their activities. Vehicles will be located and organized by club when registrants so specify in their registration information. A panel of three impartial judges, to be chosen by show organizers and Park personnel, unaffiliated with any car club in the show, will review each club's display beginning at 2PM. Criteria for judging includes but is not limited to participation, theme, uniqueness, and enthusiasm. A club display must include at least three vehicle entries to qualify.

**II. Best in Show:**

Each club will pick their top three Best in Show entries using their own criteria and judging techniques. The three judges for the Best Club Display will select three Best in Show entries from the non-club registered vehicles. Selections must be made and provided to show organizers by 2:30PM. Each club will also provide a representative to act as a Best of Show judge. The best of show judges, in conjunction with the show organizers, will jointly determine their judging criteria and pick one vehicle from all the Best in Show entries to be awarded the Best in Show prize.

**III. People's Choice:**

First, Second and third place People's Choice awards will be given based on Ballots passed to all visiting the show and the mansion, which are filled out and returned to the show entry booth or on-site show organizers.

**Presentation of Awards:**

Awards will be presented at the entertainment location sharply at 3:30PM. Vehicles and owner/operators **must** be present to receive any of the awards.
